- 3. Submit a one hundred fifty-dollar (\$150.00) filing fee made payable to the City of Garfield with the completed application.
- 4. Attach a signed and notarized copy of the Certification. (Attached)
- 5. The notice of public hearing must be published once, at least fifteen (15) days prior to the public hearing. The City Code Enforcement Official will publish the ad you provide. (See attached sample form for Notice of Public Hearing for Conditional Use Permit.)
- 6. You must notify anyone who owns or leases property, that is adjoining the property, including those across the street, of the request for the conditional use permit, and of the public hearing, by certified mail, with return receipt requested. Bring the receipt cards and any returned mail, along with a list of all recipients, to the City Hall, no later than ten (10) days prior to the meeting. A list of property owners must be prepared from the County Assessor's current tax list.
- 7. A representative is required to attend the public hearing to answer any questions from the planning commission.
- 8. If approved, you are required to purchase a business license from the City Recorder/Treasurer. (if applicable)
- 9. The permit will need to be renewed yearly on Jan. 1, or at such time as a complaint is received regarding the business. (if applicable)
- 10. If the application is submitted for an existing business, the completed application must be returned within 30 days. Failure to comply with this requirement will result in a referral to the City Attorney's office for appropriate action. (if applicable)
- 11. If there will be more than one conditional use on the property, you need to fill out an application for each conditional use
